Any unauthorized commercial activities are prohibited on IVGID property without its signed consent.

**MEDIA RELEASE:** The undersigned consents to be photographed and/or quoted and irrevocably grants to IVGID the right to use and incorporate photographs, video footage, digital images, verbal quotes and all other forms of media taken at any IVGID facility or program/event for commercial and other lawful purposes. This consent and grant of rights is unconditional and without limitation as to time or method of use including but not limited to printed materials, web sites and social media.

**INHERENT RISKS: IN CONSIDERATION OF** participating in any way in an IVGID facility, sponsored sport/activity/program or related events and activities, the undersigned acknowledges, appreciates, and agrees that the inherent risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) to myself from the activities involved in these programs are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury, illness, or death do exist.
