WAIVER OF LIABILITY - PLEASE READ & INITIAL BEFORE SIGNING

I understand launching my vessel at the boat ramp is a privilege, reserved for Incline Village residents with beach access, which may only be used for personal use. Annual Watercraft Launch Passes shall not be used for commercial use. Boat ramp privileges will be revoked in the event of noncompliance with District policies or procedures.

I understand there are inherent risks in the use of a boat ramp for the launching and recovering of a boat. The inherent risks are present at all times, regardless of weather, and include, but are not limited to: the deposit of algae causing slippery surfaces; sudden and unexpected increases in wind; low water levels that could damage boats, trailers, and/or land vehicles; unexpected failure of equipment; dangerous wave action; and collision between boats, trailers, and/or land vehicles. There are risks of serious injury, illness, or death that will exist and cannot be eliminated, and I hereby voluntarily assume these risks as part of being allowed to use Incline Village General Improvement District (IVGID) facilities for watercraft launch and recovery.

I understand that IVGID is not responsible for posting high wind warnings or small craft warnings and that any posted warnings may not reflect actual conditions. I understand that it is my sole responsibility to evaluate wind and water conditions and determine if it is safe to launch, recover or use the boat ramp for any reason.

To the fullest extent permitted by law, I (for myself and/or for my heirs, executors, and administrators), do RELEASE, HOLD HARMLESS, AND INDEMNIFY IVGID, its elected and appointed officials, officers, representatives, agents, employees, and volunteers (collectively, "Released Parties"), from any and all liability, claims, losses, or damages of any kind, including but not limited to claims for bodily injury or death, or property damage, that may arise out of my use of IVGID facilities, and hereby covenant not to sue the Released Parties, for any such claims, losses, liabilities, or damages arising out of such use, regardless of whether or not they were caused by the Released Parties' negligence. Notwithstanding the foregoing, this paragraph shall not be deemed to require the release of any claims caused by the gross negligence, recklessness, or intentional conduct of the Released Parties but only to the extent such release of claims would be prohibited by Nevada law.

I understand all trailers must be attached to a vehicle at all times when parked on IVGID property.

I hereby agree, having read and understood the above agreement and release, that by signing this form and agreement, I may be surrendering valuable rights. I do sign this release freely and voluntarily.

Apply annual pass sticker to front left windshield of the boat to which it is assigned or to the left front side of the trailer in the case of more than one PWC on one trailer. Watercraft Launch pass is non-refundable and not transferable. Vessel registration must be in applicant's name.
